3. Assessing safety and quality of food distributed in the Russian Federation. Experience of participating in the “Demography” National project.
4. Up-to-date techniques for diagnostics, correction and prevention of health disorders associated with environmental factors. New knowledge and approaches to estimating COVID-19 and solutions to the problem.
5. Contemporary aspects of occupational medicine. Assessment of occupational health risks.
6. Use of information technologies and mathematical modeling in hygienic and epidemiological studies.
